Mr. Langa:

This office serves as General Counsel to the Morristown & Erie
Railway of Morristown, N.J. (M&E). M&E recently received an
unsigned email (copy enclosed) regarding the operation this year
of the “Kringle Railway Adventure”.

M&E disagrees that it is infringing on Imaginif Inc. word mark
“Kringle”. As you know the filing on that mark specifically
speaks to live theatre performances, entertainment services namely
providing non-downloadable prerecorded on-line theatrical
presentations; live television appearances by an entertainer;
photography services and live show performances for children.

M&E operates a train ride along its rail line in New Jersey. There
is no theatrical production or live theatre on the train nor any live
actor identified as “Kringle”. In addition, we see no possibility
that anyone could confuse the train ride with the material you
promote on your website.

While we conclude that we are not infringing on your name or confusing anyone regarding your activities, we will be placing a disclaimer on our website that our use of “Kringle” is not related to or be confused with “Mr. Kringle Licensing Group LLC which is owned by Imaginif Inc. of Cleveland, Ohio.
